MESSAGE

The Employees' State Insurance Corporation since its inception in 1952, has been continuously working to provide social security and health care facilities to the insured workers and their families. Presently the services of ESIC have been expanded to 601 districts out of 740 districts. (about 80% of all Districts). Cash benefits and medical benefits are provided through 64 Regional/Sub-Regional Offices, 598 Branch Offices, 160 Hospitals and 1502 Dispensaries and Tie-up hospitals.

For extending the medical & health services to our workers, convergence of ESI Scheme with Ayushman Bharat - PMJAY has been done under which the Insured Workers of ESI Scheme and their dependants in those districts where no medical facility is available under ESI scheme, will get cashless treatment in empaneled hospitals under Ayushman Bharat. This facility has been started in designated 463 districts. Also, the beneficiaries of Ayushman Bharat can get medical care facilities in the underutilized hospitals of the ESI scheme.

ESIC continuously strives for easing the process of service delivery mechanism to the workers of our country and covering all districts of the country under ESI Scheme, for which all efforts are being made by ESIC to achieve this.

ESI Samachar would facilitate to bring the news to our stakeholders on recent initiatives and developments of ESIC which will not only educate the workers but will also empower them.

National Labour Conference

Two-day National Labour Conference of Labour Ministers and Labour Secretaries of States/UTs held at Tirupati (25th-26th August, 2022)

A two-day National Labour Conference of Labour Ministers and Labour Secretaries of States/UTs was organised at Tirupati, Andhra Pradesh on 25th-26th August, 2022. Prime Minister, Shri Narendra Modi virtually addressed the inaugural session on 25.8.2022. Shri Bhupender Yadav, Minister of Labour & Employment, Environment, Forest & Climate Change, Govt. of India, Shri Rameswar Teli, Minister of State for Labour & Employment, Govt. of India, Administrator of UT of Chandigarh, Labour Ministers of States, Labour Secretaries of States/UTs and Government Officials were among those present on the occasion.



'Swasthya se Samridhhi', one of the themes discussed during the conference pertained to ESI Scheme. The 'Swasthya se Samridhhi' was discussed for improving medical care and services through ESI hospitals run by State Governments and integration with PMJAY. Union Labour & Employment Minister mentioned that ESIC is committed to extend medical facilities to all districts by December, 2022, undertaken construction of 76 new hospitals, ready to recruit specialists for State run ESI hospitals. States stated, inter-alia, that ESIC is a standing example of cooperative federalism where states and central institutions work together for providing healthcare services to the labourers. States welcomed the revision in norms for setting up hospitals. States were requested to complete the formation of societies at the earliest for easy decision making, inputs for revision of norms for setting up new hospitals, modalities for setting up of medical colleges & hospital in aspirational districts.

On the sidelines of the Conference, an exhibition to showcase the use of latest technology in improving service delivery mechanism was held by ESIC in which State Governments also participated alongwith other organistaions of Ministry of Labour & Employment, Govt. of India. ESIC Medical College & Hospital, Faridabad, Hyderabad and Chennai showcased the innovative technology used in patient care and administration. Property Management Division showcased use of drone technology in monitoring the ongoing construction projects of ESIC.

Home Minister lays the foundation of 350 bedded ESIC Hospital, Sanand, Gujarat

Shri Amit Shah, Union Minister for Home Affairs and Co-operation laid the foundation stone of 350 bedded (upgradable to 500 bedded) ESIC hospital Sanand, Ahmedabad, Gujarat on 26th Sep 2022. The 350 bedded hospital will have all modern facilities. Construction of the hospital spread over 9.5 acres would entail an expenditure of ₹ 500 Cr. This hospital will cater to 12 lakh employees and their families.

Speaking at the occasion, Shri Bhupender Yadav, Minister of Labour and Employment, Environment, Forest and Climate Change, Govt. of India shared that with the co-operation of state and the administration, it is possible to achieve the results efficiently. He said that the 500 bedded hospital would be among the most modern hospitals with best medical facilities.

ईएसआईसी अस्पताल, कलोल, गुजरात का शिलान्यास

ईएसआईसी बीमित कामगारों की चिकित्सा देखभाल की जरूरतों को पूरा करने के लिए श्री अमित शाह, गृह एवं सहकारिता मंत्री, भारत सरकार द्वारा 27 सितंबर, 2022 को 150 बिस्तरों वाले ईएसआईसी अस्पताल, कलोल, गुजरात का शिलान्यास किया गया। 150 बिस्तरों वाला ईएसआईसी अस्पताल 4.05 एकड़ के भूखंड क्षेत्र में बनाया जाएगा, जिसकी अनुमानित लागत ₹ 150 करोड़ होगी। इससे कलोल, कडी और गांधीनगर के आसपास के क्षेत्रों के लगभग 04 लाख लाभार्थी लाभान्वित होंगे। इसमें आईसीयू, ओटी, सामान्य चिकित्सा, सर्जरी, प्रसूति और स्त्री रोग, बाल रोग और नवजात विज्ञान, त्वचाविज्ञान, अल्ट्रासाउंड और कई अन्य सुविधाएं जैसी आधुनिक सुविधाएं होंगी।

Online Maternity Benefit claim facility

Online Maternity Benefit claim Portal was started by ESIC. Shri Bhupender Yadav, Union Minister of Labour & Employment and Environment, Forest & Climate Change launched the ESIC Online Maternity Benefit claim facility on 10th Nov, 2022 during the commemoration of 102nd Birth Anniversary of Shri Dattopant Thengadi at Vigyan Bhawan, New Delhi.

The newly introduced facility will ease the process of claiming maternity benefits for insured women as the process has now been made online, where the beneficiaries at their convenience, can now claim maternity benefits from anywhere. Earlier, the beneficiaries for claiming the maternity benefits had to visit the respective branch offices physically.

Maternity benefit is given to the insured women in the form of cash benefit in case of certain contingencies such as in the advanced stage of pregnancy or those who meet the eligibility conditions. A total of 18.69 lakh women beneficiaries have been provided maternity benefit of ₹ 37.37 crore during the year 2021-22.

The ISSA promotes excellence in social security administration through professional guidelines, expert knowledge, services and support to enable its members to develop dynamic social security systems and policy throughout the world.

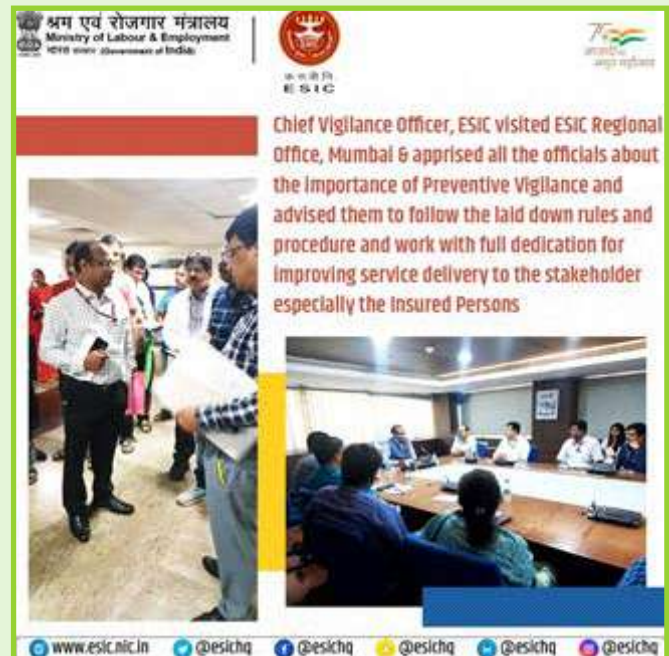
The ISSA was founded in 1927 under the auspices of the International Labour Organization (ILO), Geneva and has over 320 Member Institutions from over 160 countries.
